

US Export Controls Classification Information

RIM products provide encryption features that are subject to the U.S. Export Administration Regulations ("EAR") and other U.S. laws when in or exported from the United States. The EAR classifications of RIM products that have been reviewed by the U.S. Bureau of Industry and Security are set out in the chart below.

All of the BlackBerry software and hardware covered by the chart may be exported under the EAR to most destinations with No License Required ("NLR"). However, these items may not be exported and re-exported to certain countries (currently Cuba, Iran, North Korea, Sudan and Syria) or to persons or entities prohibited from receiving U.S. exports, including those (a) on the Bureau of Industry and Security Denied Parties List or Entity List, (b) on the Office of Foreign Assets Control list of Specially Designated Nationals and Blocked Persons, and (c) involved with missile technology, nuclear, chemical or biological weapons, or military end-uses where prohibited by an applicable arms embargo.
